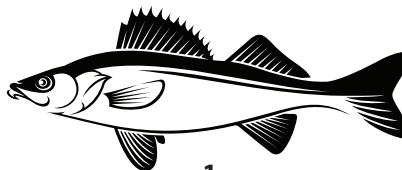
Greetings from the Minnewaska Lake Association (MLA). The spring and summer of 2024 provided great fishing opportunities on Lake Minnewaska. Walleye fishing was excellent, with many limits taken throughout the lake. The sunfish, bass, and northern pike were abundant. This past winter we had a return to more uniform ice conditions. There were many fish houses on the lake and the sunfish, crappie, and walleye fishing was productive.

Minnewaska became recognized as a MN Keep It Clean Lake this year (in conjunction with the 2023 MN State Law) and MLA organized an end of season ice clean-up event in partnership with Lakeside scheduled for March 2, 2025. Unfortunately, the prior week brought unseasonably warm temperatures including a rainstorm and the event was cancelled due to uncertain ice conditions and safety concerns for participants.

MLA held our 24th Annual Banquet on June 29, 2024, at the Minnewaska House. Once again, we had a complete SELL OUT at the banquet. Because of the GREAT support we received from donors and those who attended last summer, it was another successful Banquet.

We are looking forward to the 25th Annual MLA Banquet scheduled for Saturday, June 28, 2025. It will once again be held at the Minnewaska House. Because of the complete sell-out for the last two years, we highly recommend that you get your tickets early. They will be printed by early April and you can mail in your payment for the memberships, donations, and tickets using the form on the back page of this newsletter. These tickets will be mailed to you. Please be aware: Banquet tickets have been selling out early. We will post to our website when sold out.

The MLA is a 501(c)3 non-profit organization, so your donations are tax-deductible. Memberships, banquets, and donations are the primary funding sources for MLA projects. We are planning several projects in 2025, and we hope you will consider renewing your membership and donating to help us make these projects possible. MLA is dedicated to the preservation of Lake Minnewaska.





The MLA continues to coordinate with the Mayor and City Council of Starbuck regarding Aquatic Invasive Species surveys and treatments in the Starbuck Marina and the main lake- please refer to more details in this newsletter. The reconstruction of the Starbuck Marina lighthouse, which was destroyed in a 2022 storm, was completed in September 2024 and once again serves as a landmark and provides safety for night time boaters.

This past winter, MLA donated and delivered two cabinet mounted Automated External Defibrillators (AED's) to the cities of Glenwood and Starbuck. They are installed on the outside of the concession stand buildings at each of the city beaches as life safety devices and are available year-round to the public if needed for a cardiac emergency.

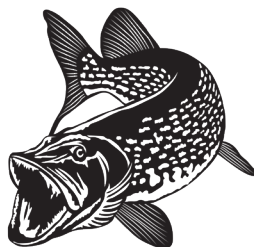

WALLEYE STOCKING PROGRAM:

MLA started the walleye stocking program in 1998 and has continued to stock thousands of walleye fingerlings every year since. Each fall we stock 2,000 pounds of fingerlings (by DNR permit) with an average length of 6" to 8". This equates to about 40,000 to 50,000 fingerlings every year and has resulted in some of the best walleye fishing in the state. Also, the local DNR has reported stocking 3.3 million fry in Lake Minnewaska in the spring of 2024.

Please consider keeping northern pike under 22" and over 26". State law requires that all northern pike 22" to 26" be released. Per reports from the local MN DNR, there is an overabundance of small northern pike in Minnewaska. The small northern pike is excellent for pickling. There is also an abundance of largemouth Bass. Please consider keeping the northern pike and bass you catch as this will help Walleye and Perch survival rates.

Fishing has been great the last three years with numerous 12-14" walleyes reported so the future looks favorable. MLA recommends releasing walleyes under 15" length to maintain natural reproduction and growth cycles. Please refer to the MN DNR fishing regulations for details on all species and observe daily/possession limits.

With the excellent fishing opportunities on Lake Minnewaska across many species, we continue to see more people coming to our lake to enjoy this great natural resource. This helps to support the local businesses and surrounding communities.

THE FIGHT AGAINST AQUATIC INVASIVE SPECIES (AIS):

MLA is dedicated to maintaining a proactive and evidence-based AIS management plan to help protect the Lake Minnewaska ecosystem, water quality, and recreational opportunities.

We continue to work with respected professional service providers for AIS lake surveying (Blue Water Science) and treatment plans (Tigris) using proven products with minimal ecological impact as recommended by industry experts and backed by scientific studies.

MLA will again in 2025 provide treatments for Starry Stonewort and Eurasian Watermilfoil in the main lake and coordinate with the City of Starbuck for their treatments in the Starbuck Marina. By coordinating the treatment in the marina with the treatment in the main lake it reduces the cost by eliminating additional mobilization.

This year we will proactively expand our pre-treatment lake surveys to include four (4) additional boat landings on the main lake to get an early indication of any incoming AIS concerns. The MLA has received the required permits and secured grants to survey and treat Eurasian Watermilfoil and Starry Stonewort in the main lake in 2025 and we have contracted with Blue Water Science and Tigris for the surveys and treatment applications.

STARRY STONEWORT PROJECT (SSW):

SSW was discovered in the Starbuck Marina in August 2017. SSW has also been found in the main channel just outside the Marina. Over each of the last several years since discovery, the MLA has been proactively working to contain the Starry Stonewort issue including expanded survey areas in 2023 and again in 2025.

There are currently no available treatments to eradicate SSW so it is critical that we continue our efforts to minimize the spread.

Our initial SSW treatments in 2018 covered 1.5 acres. In 2024 we identified and treated 1.7 acres. It is encouraging that the 2024 surveys indicated that SSW appears to be contained within the treatment area. In 2025, the MLA will survey 5 acres outside the Marina plus the areas around four (4) boat ramps on the main lake and provide treatments accordingly.

EURASIAN WATERMILFOIL PROJECT (EWM):

MLA has been fighting EWM since 2013, initially treating over 40 acres. In the years since, we have had good success treating this aquatic invasive species. In 2023, we began treating EWM with a new product called ProcellaCOR. Although this is a more expensive option, it is very eco-friendly and has shown results in killing and controlling the spread of EWM for up to three years.

Lake Minnewaska covers many acres of water and it is not realistic to think we will be able to fully eradicate EWM from the lake. Due to continuing MLA efforts, we are finding many previous treatment sites where the native vegetation has taken over, stunting the growth of EWM.

In 2024 we found 8.4 acres of treatable EWM and the treatment was applied in mid-July. Post-treatment surveys showed good success in reducing and containing EWM.

The MLA in 2025 will conduct the required pre-treatment meandering survey of 18 acres in June or early July where we have found EWM in the past to determine the infested areas for treatment in 2025. With relatively light snow cover and an early anticipated ice-out this year, we are expecting more weed growth in 2025. The exact timing of the survey and treatments will be based on the weather and water conditions this spring. We will continue our work to control the spread of EWM over the coming years.

THRIVENT ENDORSEMENT:

MLA FISH & CRUISE:

MLA has a program called "MLA Fish & Cruise," which aims to enrich people's lives by providing on-the-water experiences for area seniors and veterans. Fishing trips and cruises are provided to these individuals at no cost due to the generous support from businesses and organizations listed on the side of our pontoon. We are looking for more people who would consider becoming Captains or helpers for these outings. We will provide the necessary training to ensure a safe and enjoyable experience.

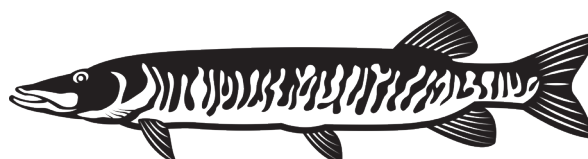
MEMBERSHIP

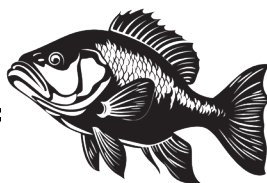

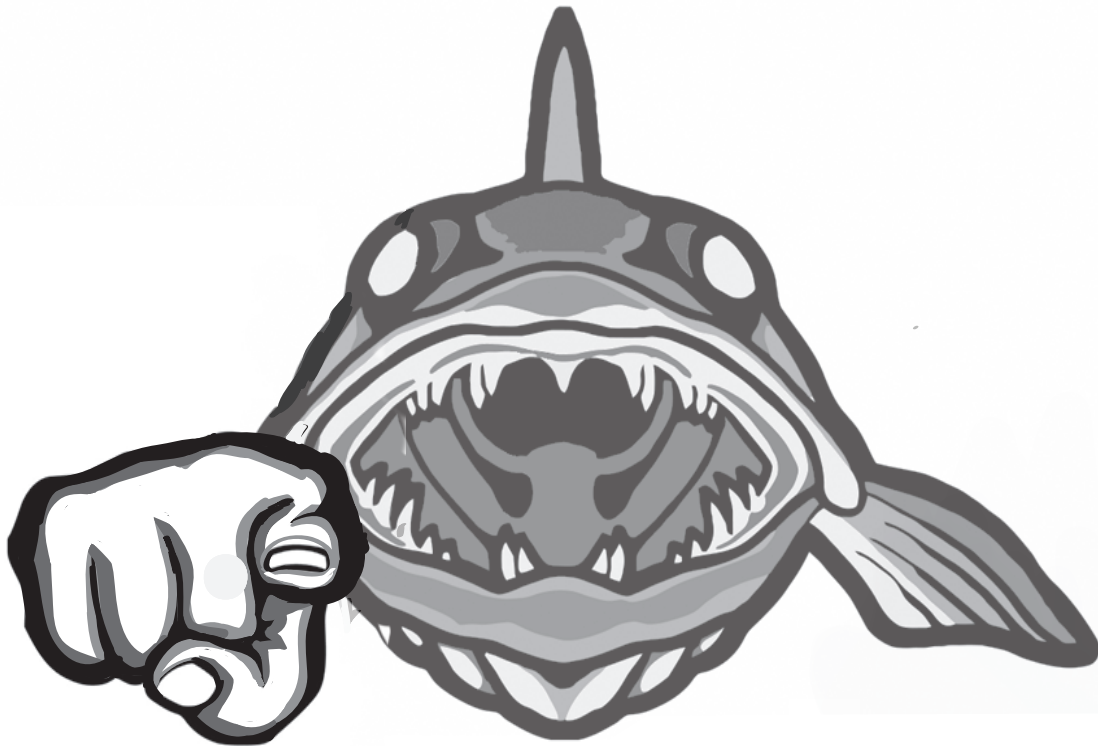
